

To safeguard laborers' rights to unionization, to collective agreement and to collective negotiation, the amendments define unfair labor practices, clarify issues such as union members' entitlement to the so-called "union attendance leave" and to joining multiple unions. They also distinguish the difference between the newly created mode of "decisions" vis-a-vis traditional court judgments.
